**Ingredients:** Water, Green Tea Extract C.G., Zemea® propanediol, HONEY ZEA-BOTANICALS®, TEXTURLUX® stabil, Keltrol® CG, TEXTURLUX® rheo

#### Procedure

1. Heat A to 50C
2. Premix B and add to A with propeller stirring until completely smooth and uniform
3. Add C with propeller stirring until uniform
